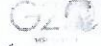

Konkan Education and Medical Trust, Virar Homoeopathic Medical College, Veer Savarkar Marg, Virar, Tal. Vasai, Thane - 401305, Maharashtra is functional since 1994 and has submitted an application for permission for sanction of 75 seats in BHMS course for the academic year 23-24, in which the entire functional profile has been narrated. The application has been examined by Medical Assessment and Rating Board for Homoeopathy as to whether the college fulfils the Minimum Standard Requirement to be fulfilled as per the prevailing regulations under NCH Act 2020 and conducted the Inspection of college on 24.08.2023 and 25/08/2023. Accordingly, it is to inform you that inspection reports submitted by inspectors, were examined by the Medical Assessment and Rating Board and following deficiencies were noticed:

I. College

Teaching Faculty

1. As per MSR-2013 for 75 seats 28 full time teaching faculty is required but only 26 faculty presently working in institution, 02 posts are vacant mentioned as under,
 - i. Professor- Dept. of Practice of Medicine-01 post
 - ii. Professor- Dept. of Repertory-01 post

II. Hospital

1. 03 ward boys were appointed against the requirement of 04 ward boys.
2. College Hospital provided data of 200 patients per day, but on the day of visitation 24 patients were entered in OPD central register at 10:30 AM.
3. While random checking of OPD & IPD case records, it found that Analysis evaluation and repertorisation not done by Internees.
4. In majority of case records there is no signature of Attending doctor.

V. IPD

At the time of visitation 5 Patients admitted in male ward & 4 patients admitted in female ward, while enquiring with the patient, it is informed that seems few patients were admitted at the time of visitation.

College is required to follow standard guidelines in the functionality as under:

- a) Case records should be well maintained in respect of case analysis, evaluation and repertorization and made available in Medical Record Room for academic purpose of students and follow up attendance of patients.
- b) Case sheets should have complete demographic details and contact details of patients.
- c) Diagnosis should be written in ICD 11 criteria

Considering the above facilities and shortfalls, Medical Assessment and Rating Board for Homoeopathy has decided to issue **conditional permission to Konkan Education and Medical Trust, Virar Homoeopathic Medical College, Veer Savarkar Marg, Virar, Tal. Vasai, Thane - 401305, Maharashtra with intake capacity of 75 seats in undergraduate course (BHMS) for the academic year 2023-24.** The shortfalls observed in your College shall be rectified within a period of 15 days and compliance report shall be submitted to the MARBH failing which the conditional permission issued will be withdrawn without further notice.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by Medical Assessment and Rating Board.


