MEMORANDUM OF UNDERSTANDING

BETWEEN

KEMT's Virar Homoeopathic Medical College & Hospital Party No. 1 Address: - Naringi Bypass Road, Virar (E), Tal. Vasai, Dist. Palghar, Pin – 401 305

AND

Riddhi Vinayak Multispeciality Hospital (R.V.M.H.). Party No.2 Address: Plot No. 302, Near Railway Carshed, Ahead of Fun Fiesta on Yashwant Gaurav Road, Virar Nalasopara Link Rd., Nalasopara(W), Dist. Palghar

This MOU is between KEMT's Virar Homoeopathic Medical College's Hospital,RVMH, Nalasopara (W) for Clinical Training Programme for Interns/Students & will commence from 1st February, 2020. The College & Hospital will not have any monetory exchanges as this is in friendly spirit.

1) Our College Hospital will refer patients from our IPD/OPD for Hospitalization, USG, CT Scan & other advanced care to RVMH as and when required.

2) RVMH & VHMC to run a joint clinical training programme for Interns/Students.

3) RVMH is giving permission for clinical training programme for Interns and students (3rd & 4th year students) for enhancement of their clinical knowledge.

4) During this training of clinical sessions, Students/Interns will not be paid any stipend.

5) Any misconduct by Interns/Students of VHMC should be reported to the college so that necessary action can be taken.

6) Time table for per session will be made by mutual understanding.

- 7) Students will attend clinical sessions in time table decided by mutual adjustment suitable to both parties.
- 8) Interns will attend for 6 days in a week in batches. Interns rotation will be decided by mutual coordination.
- 9) RVMH will identify the departments in which Interns/Students can participate for OPD/IPD/OT and inform the college accordingly.

10) Attendance of Interns/students will be maintained by the Hospital & submitted to the college at the end of each rotation.

11) Interns/Students of College are not authorised to do any paper work/ change treatment plan of patient or sign any certificates pertaining to patients admitted in the hospital.

12) All various responsibility of the Interns lies with the Hospital hence paper work to be designated accordingly.

Any change will be implemented in coordination with the Hospital & College and reviewed as per necessity.

14) The right for cancellation or extension of M.O.U. will be mutually decided.

15) This MOU will be valid for Five years and can be renewed afterwards mutually.

16) RVMH & VHMC to conduct joint seminar/Workshop/other education and community awareness programmes using each other's faculties and facilities.

A Joint co-ordinating committee comprising of one staff member from both the parties will maintain the day to day affairs.

It is expected that mutual goodwill and respect will carry the arrangement through though if necessity arises The MOU can be terminated by mutual understanding giving one month prior notice. Any dispute would be settled in a spirit of cooperation and friendship.

This M.O.U. is valid from 1st February, 2020 for Five Years till 31st January, 2025.

- 2. The College shall conduct classes for the students and lectures shall be conducted by the Consultants of the Hospital with due fixed honorarium.
- 3. It shall be the obligation of the College to appoint adequately qualified staff to attend to the patients admitted in the Hospital to meet the academic needs of the College.
- 4. The college shall use the transport service of the hospital on use and pay basis namely,
 - Ambulance Services.
 - Bus services for to and fro transport of students between the College & Hospital campus
- 5. This agreement between both the parties shall serve as a common MOU for the use of Hospital premises, for all radiological & Pathology Laboratory investigation facilities and Ambulance facilities.
